#### **Minutes of Meeting**

#### I. Call to Order

- **A. Chairman Jenkins** called the meeting to order. The attending members constituted a quorum.
- **B.** Audience Participation

None.

#### II. Minutes – Motion Required

#### A. Approval of Minutes

Members were asked to approve the minutes of the September 26, 2024 meeting.

#### Motion

**Paul Adamson** made a motion to approve the minutes and it was seconded by **Bobbie Beshara**. The motion was approved by a voice vote.

#### III. Staff Reports

#### A. Financial Progress Report

Curtis Baker presented Attachment 3A.

#### Motion

William B. Judge made a motion to approve the Financial Progress Report and it was seconded by Carol Siciliano-Kilway. The motion was approved by a voice vote.

#### **B.** Technical Progress Report

**Matt Stewart** said that the Staff is still scheduling *Transportation Outlook 2050* (*TO2050*) meetings with communities to discuss their respective long-range goals and projects. **Mr. Stewart** noted that *TO2050* and the upcoming FY 2026-2029 TIP will be developed concurrently. **Mr. Stewart** said that draft project lists for

*TO2050* and the TIP should be ready by the Policy Committee's February meeting.

#### C. AMATS Federal Funds Report

Amy Prater presented Attachment 3C.

**Ms. Prater** presented tables concerning STBG, CRP, CMAQ, and TASA Funding Program and Balances dated Nov. 26, 2024.

#### IV. Old Business

A. Congestion Management Process (CMP) Report.

Mr. Baker presented Attachment 4A.

#### **Motion**

**Joe Paradise** made a motion to accept the CMP Report and it was seconded by **Rocco Yeargin**. The motion was approved.

#### V. New Business

A. Traffic Crashes and Safety Performance Measures (2021-2023).

Mr. Stewart presented Attachment 5A.

**Mr. Stewart** praised AMATS TIP Coordinator Amy Prater for her diligent work in compiling the crash data for the *2021-2023 Crash Report*.

Mayor Yeargin asked how the crash totals fit into overall level of traffic usage and patterns in the Greater Akron area. Mr. Stewart noted that Section 2 of the 2021-2023 Crash Report addresses regional traffic volume and the COVID-19 pandemic's impact. Mr. Stewart observed that regional traffic crash totals declined during the pandemic while fatalities increased, which mirrored national totals. Mr. Stewart added that recent regional traffic volumes are approaching pre-pandemic levels while total crashes are still lagging.

Mayor Yeargin asked why total crashes have not returned to their pre-pandemic level. Mr. Stewart suggested that the totals may be due to crash prevention features available on new vehicles and regional investments in safety improvement projects. However, there are more opportunities for distracted driving. Mr. Stewart stated that total crashes remain low while severe crashes are increasing, which may be due to risky behavior while driving.

**Mayor Yeargin** asked if the complete 2021-2023 Crash Report is available through the online meeting materials and if information is stratified by community. **Mr. Stewart** said yes and noted that additional information by

community is available through the *Safe Streets for All (SS4A) Action Plan*, which is also on the agency website – **amatsplanning.org**.

#### Motion

**Jim Bowling** made a motion to accept the Traffic Crashes and Safety Performance Measures (2021-2023) and it was seconded by **Joe Paradise**. <u>The motion was approved</u>.

#### B. Update to the AMATS Public Participation Plan -3P.

Jeff Gardner presented Attachment 5B.

#### **Motion**

**Bobbie Beshara** made a motion to accept the Update to the AMATS Public Participation Plan – 3P and it was seconded by **William B. Judge**. <u>The motion was approved</u>.

#### C. Regional Discussion of Passenger Rail.

Mr. Baker said that the Ohio Rail Development Commission (ORDC) recently announced its intention to study the feasibility of intercity passenger rail service along the Cleveland-Columbus-Cincinnati Plus Dayton (3C+Dayton) and the Cleveland-Toledo-Detroit rail corridors. Mr. Baker said that Congresswoman Emilia Sykes (D-13) questioned the Greater Akron area's exclusion from consideration as part of the 3C+Dayton corridor and is urging a feasibility study regarding the possible linking of the area to the corridor. The ORDC has indicated that Akron lacks a suitable rail connection to the 3C+Dayton corridor and that determining such a connection would likely require a separate feasibility study.

**Mr. Baker** said that AMATS has considered the issue of area passenger rail service in the past. **Mr. Baker** explained that, while the agency is broadly supportive of the concept of passenger rail service, there has been a general acknowledgement among AMATS members that the area is not suitable for such service, especially in the absence of an east-west Class I rail line that could link with the 3C+Dayton corridor. **Mr. Baker** added that regional pursuit of rail service would be difficult if it is not part of a larger, sustained national effort given the area's transportation needs and limited funding resources.

**Mr. Baker** suggested that AMATS consider including language in the upcoming *TO2050* stating the agency's general support for passenger rail service and the Greater Akron area's future linkage to the 3C+Dayton corridor, when and if deemed possible. **Mr. Baker** noted that the TAC approved a resolution during its Dec. 5 meeting stating that, while AMATS does not oppose passenger rail service and supports the inclusion of the Greater Akron area in potential rail studies, the agency may not presently be the most appropriate entity to pursue funding for such a feasibility study.

**Diane Miller-Dawson** asked whether the AMATS Staff has discussed the issue with Summit County Executive Ilene Shapiro. **Mr. Baker** said no, but is available to discuss the issue with the executive. **Mr. Baker** noted that the Greater Akron Chamber recently initiated discussion regarding passenger rail service with AMATS.

**Mayor Yeargin** asked why Dayton is included in the rail corridor discussions and not the Greater Akron area. **Mr. Baker** explained that there is a Class I rail network that extends to Dayton that would provide access to a potential corridor. No such network exists to provide access to the Greater Akron area.

The members discussed the potential benefits and consequences of AMATS addressing passenger rail service in the *TO2050*.

**Mayor Yeargin** said that he would like AMATS to express its support for passenger rail service. **Mayor Yeargin** expressed support for a potential passenger rail connection to the Akron-Canton Airport. **Mr. Baker** noted that the ORDC indicated that intercity passenger rail ordinarily does not connect to airports.

**Dawn Distler** said that AMATS issuing a statement of support for intercity passenger rail service would position the region and the state to pursue potential funding opportunities to study the issue. **Ms. Distler** said that a potential rail corridor should extend along the Interstate 71 corridor. **Ms. Distler** noted that there are FTA grants available for planning studies, but added that other entities must express support to pursue a study rather than AMATS alone.

Michelle DiFiore asked whether there were two ORDC studies in Ohio. Mr. Baker said yes and added that ORDC and the Mid-Ohio Regional Planning Commission (MORPC) are conducting a study of a Pittsburgh-Columbus-Fort Wayne corridor. Ms. DiFiore asked whether any Greater Akron area organizations are involved with the ORDC-MORPC study. Mr. Baker said that no area organizations are involved in the ORDC-MORPC study.

**Chairman Jenkins** asked Mr. Baker to describe the TAC's Dec. 5 resolution. **Mr. Baker** described the resolution. **Chairman Jenkins** polled the Policy Committee as to whether the committee wanted to approve a resolution concurring with or opposing the TAC resolution.

The members discussed the merit of the TAC resolution. The Policy Committee agreed to ask the AMATS Staff to draft a resolution stating the committee's position regarding the inclusion of intercity passenger rail service and related studies in the upcoming long-range regional transportation plan, *TO2050*. **Mayor Yeargin** asked if a draft resolution could be ready for consideration by the Policy Committee's anticipated Feb. 13, 2025 meeting. **Mr. Baker** said yes.

#### Motion

**Bobbie Beshara** made a motion to direct the AMATS Technical Staff to prepare a resolution stating the AMATS Policy Committee's position regarding the committee's support of intercity passenger rail service to the Greater Akron area and related issues pertaining to the study of such service for inclusion in the Draft Transportation Outlook 2050 and it was seconded by **Paul Adamson**. The motion was approved.

#### VI. Resolutions

## C. Regional Discussion of Passenger Rail.

**Mr. Baker** said that the Ohio Rail Development Commission (ORDC) recently announced its intention to study the feasibility of intercity passenger rail service along the Cleveland-Columbus-Cincinnati Plus Dayton (3C+Dayton) rail corridor. **Mr. Baker** said that Congresswoman Emilia Sykes (D-13) questioned the Greater Akron area's exclusion from consideration as part of this potential corridor and is urging a feasibility study linking the area to the 3C+Dayton corridor.

**Mr. Baker** said that Congresswoman Sykes began a dialogue with the Greater Akron Chamber regarding this issue. The chamber, in turn, has approached AMATS requesting additional information regarding the potential for rail service

to the region. **Mr. Baker** said that AMATS has considered the issue of area passenger rail service in the past and found that the area is not suitable for such a service, especially in the absence of an east-west Class I rail line that could link with the 3C+Dayton corridor.

**Mr. Baker** said that the chamber is urging AMATS to address passenger rail service in the upcoming long-range plan. **Mr. Baker** added that the chamber is also urging AMATS to seek federal funding to study potential passenger rail service to the Greater Akron area.

**Mr. Baker** polled the TAC members regarding the various rail issues and stated that the committee's position would be relayed to the AMATS Policy Committee during that committee's Dec. 12 meeting.

Several committee members noted that the proposed passenger rail service along the 3C+Dayton corridor would not meet the definition of "high-speed" rail.

The TAC reached a broad consensus that AMATS is not opposed to passenger rail service in principle nor its consideration or mention in the AMATS long-range regional transportation plan.

The TAC agreed that further study of the inclusion of the Greater Akron area in the proposed 3C+Dayton corridor may be warranted, but that AMATS - given its limited financial, technical, and staffing resources - may not be the appropriate agency to pursue such a study. The members concurred that the agency - in its role as the area's metropolitan planning organization - must meet the region's current transportation funding and planning needs and obligations. The members expressed general support for another entity to lead such a study.

The attendees agreed that the TAC should approve a resolution stating its position and forward such a resolution to the AMATS Policy Committee for consideration. **Chairman Finney** called for a resolution.

#### Motion

Joe Paradise made a motion stating that, while AMATS does not oppose passenger rail service and supports the inclusion of the Greater Akron area in potential rail studies, the agency may not presently be the most appropriate entity to pursue funding for such a feasibility study, and it was seconded by Jim Bowling. The motion was approved.

#### VI. Resolutions

## Akron Metropolitan Area Transportation Study Citizens Involvement Committee Thursday, December 5, 2024 – 6:30 p.m.

#### **Meeting Summary**

#### I. Welcome

Matt Stewart welcomed the AMATS Citizens Involvement Committee (CIC) meeting attendees.

#### **II.** <u>Discussion Items</u>

- **A. Mr. Stewart** presented Attachment 4A *Congestion Management Process (CMP) Report.*
- **B. Mr. Stewart** presented Attachment 5A *Traffic Crashes and Safety Performance Measures (2021-2023).* 
  - **David H. Mangold** asked what the communities of Doylestown, Peninsula, and Mantua were doing differently than other communities to account for their lack of pedestrian-related crashes. **Mr. Stewart** observed that traffic slows considerably through Peninsula, which may account for its lack of pedestrian-related crashes.
  - Mr. Mangold asked if Doylestown utilized traffic-calming measures or had effective police enforcement that accounted for its low crash totals. Mr. Mangold urged AMATS to identify which measures were effective in these communities and to urge their adoption elsewhere in the Greater Akron area. Mr. Stewart suggested that the low totals may be attributable to the small size, low traffic volumes, and low travel speeds within the three communities.
  - **Mr. Mangold** asked if rail-related crashes were considered in AMATS crash analysis data. **Mr. Stewart** said that the AMATS 2024 Freight Plan quantified rail-related crashes. **Seth Bush** noted that the 2021-2023 Crash Report does not exclude such crash data.

The attendees discussed the potential analysis of animal-related crashes.

- C. **Jeff Gardner** presented Attachment 5B Update to the *AMATS Public Participation Plan 3P*.
- **D.** Matt Mullen presented Attachment 7A 2025 AMATS Meeting Calendar.
- E. Mr. Mangold noted that the December agendas for the AMATS Technical Advisory Committee (TAC) and AMATS Policy Committee included Agenda Item 5C Regional Discussion of Passenger Rail. Mr. Mangold asked Mr. Stewart if he knew what that item entailed.

Mr. Stewart summarized events related to Item 5C. Mr. Stewart said that the Ohio Rail Development Commission (ORDC) recently announced its intention to study the feasibility of intercity passenger rail service along the Cleveland-Columbus-Cincinnati Plus Dayton (3C+Dayton) rail corridor. Mr. Stewart said that Congresswoman Emilia Sykes (D-13) was concerned about the Greater Akron area's exclusion from consideration as part of this potential corridor and is urging a feasibility study linking the area to the 3C+Dayton corridor. Mr. Stewart said that Congresswoman Sykes began a dialogue with the Greater Akron Chamber regarding this issue. The chamber, in turn, has approached AMATS requesting additional information regarding the potential for rail service to the region.

**Mr. Stewart** explained that the agenda item was to allow the TAC and the AMATS Policy Committee an opportunity to discuss whether the Greater Akron area should become involved in these rail-related issues.

**Mr. Mangold** expressed support for extending passenger rail service to Akron. **Mr. Mangold** noted that such service would require the preservation of rail rights-of-way.

**Ron Brubaker** asked which rail corridors would be considered for passenger rail service. **Mr. Stewart** said that specific routes have not been discussed as potential study of rail service is in its preliminary stages.

F. Tiffany Jones asked for additional information about Attachment 6A – Resolution 2024-20 – To Add Ohio Workforce Mobility Program Funds for PARTA (FY 2024-2027 TIP Amendment #10). Mr. Gardner explained that the purpose of Amendment #10 to the Transportation Improvement Program (TIP) is to include new funding for five Portage Area Transportation Authority (PARTA) projects in Fiscal Year 2025. Mr. Gardner described the projects.

#### III. Adjournment

There being no other business, the meeting was adjourned.

The next meeting of the CIC is scheduled for 6:30 p.m. on Thursday, February 6, 2025.

AMATS is currently in the third quarter of FY 2025 and only one project (PID 107930 – Freedom Trail Phase 4) has sold. The right-of-way phase of PID 116742 (Wyoga Lake Rd) in STBG and PID 116917 (Arlington Rd) in CMAQ have encumbered. Also, Air Quality and Rideshare of the CMAQ funds have encumbered. Based on the latest information available, AMATS expects that many projects are close to bidding and will sell by the end of the 3<sup>rd</sup> quarter (March 31).

AMATS will probably be looking for loans for STBG, CMAQ, and TASA projects later this fiscal year as the current FY 2024 carryover did not cover all FY 2025 projects. Loans can't be requested until more projects sell as the "need" is currently not there. The next project review meeting will be February 26<sup>th</sup> for D4 and March 6<sup>th</sup> for D3. In addition to regular project discussions some projects will be asked to move to a later year due to fiscal constraints of the upcoming TIP.

**DATE:** January 29, 2025

A draft Transportation Planning Work Program and Budget is submitted annually to ODOT for review. The Work Program identifies the AMATS staff planning activities that will take place in the upcoming fiscal year and describes the funding sources that will be used to pay for them. Once ODOT completes its review of the Work Program, it is presented to the Policy Committee for final adoption in May.

AMATS members receive almost \$20 million annually in several funding categories to be used for highway, transit and enhancement improvements. AMATS is the federally mandated conduit for these funds.

The major source of funding for staff activities listed in the Work Program is United States Department of Transportation (USDOT) Consolidated Planning funding. Other sources of revenue include federal Congestion Mitigation/Air Quality (CMAQ) funds, as well as state and local funds.

It has been estimated that \$1,471,777 in federal Consolidated Planning Grant (CPG) funds will be available to AMATS for planning activities in FY 2026. These funds must be matched by state and local funds at a percentage rate of 80/10/10, yielding a total FY 2026 base budget of \$1,839,722. Remaining funds from this fiscal year (FY 2025) will be carried over on July 1 and may be used through December 31, 2025.

The local match for FY 2026 is calculated to be \$183,972. Local share funds may also be used in matching federal CMAQ dollars as part of the Rideshare and Air Quality Programs, where applicable.

Table 1 shows the draft local share calculation for each individual member of AMATS. Each member's contribution is based on the dues structure established by the Policy Committee in 2005. The dues structure is based on population. Local share amounts were modified following the release of the 2020 Census figures in December 2021.

As a result, the FY 2026 per capita assessment for each community has been set at \$0.225. In addition, METRO and PARTA will be assessed collectively \$31,227.

Table 2 shows the work elements and major planning tasks for FY 2026. Key activities include:

- Maintaining the new Transportation Improvement Program (FY 2026-2029)
- Soliciting applications for a new round of STBG and TASA funding
- Providing the annual Congestion Management Process update
- Participating in the Statewide CMAQ Discretionary Funds Program
- Directing the Gohio Commute and Air Quality Advocacy Programs
- Continuing to integrate performance measures as part of the Plan and TIP processes
- Reviewing Title VI Civil Rights and Environmental Justice documentation
- Documenting public participation activities
- Continuing the Pavement Condition Data Collection and Analysis Program
- Beginning a new round of Connecting Communities Planning Grants
- Continuing to develop a Road Diet Analysis
- SS4A Action Plan update
- Develop a new 3P Public Participation Plan
- Continued implementation of the Infrastructure Investment and Jobs Act (IIJA)

Table 3 summarizes all funds budgeted in the Work Program by source. Also included in Table 3 are planning activities performed by METRO and PARTA.

The Staff is requesting approval of the draft *FY 2026 Transportation Planning Work Program and Budget* and asks for permission to submit it to ODOT for review. The Staff will then meet with ODOT in March to discuss any comments. A final version of the Work Program will be submitted for Policy Committee approval in May. The state fiscal year begins on July 1.


The Transportation Improvement Program (TIP) FY 2026-2029 contains a comprehensive listing of regional transportation improvement projects scheduled for implementation with federal or state funds within the next four years. The TIP FY 2026-2029 was developed by the AMATS staff in conjunction with all AMATS committees, area transit operators, the Ohio Department of Transportation (ODOT) and US DOT.

A list and map of highway projects and two tables of transit projects that are currently scheduled in the TIP are being presented for your review. The highway list includes project PID, location, description, funding by year by phase and by type, air quality status, and performance measures. The transit lists include project descriptions and funding by year by type. Federal regulations derived from the *Bipartisan Infrastructure Law (BIL)* require that the TIP demonstrate financial constraint and air quality conformity. Some of these projects may be moved to different years, or outside of the FY 2026-2029 TIP period, in the next draft due to financial constraint requirements.

The entire draft TIP will be presented in March and will include opportunities for public comment. The official public comment period for the FY 2026-2029 TIP is from March 11 to April 11, although comments can be submitted at any time.

The Staff requests you review the projects in the FY 2026-2029 TIP and submit any questions or comments.



Every four years, AMATS is responsible for completing a Regional Transportation Plan. AMATS' latest Plan, *Transportation Outlook 2050 (TO2050)*, is scheduled to be completed in May of 2025. *TO2050* must contain project recommendations for the greater Akron region that are fiscally constrained, meaning AMATS must forecast sufficient future funds which will be available for these project recommendations. All projects must be consistent with the Plan to receive funding through the *Transportation Improvement Program*. As in the last Plan, preservation, safety and operational improvements are considered consistent with the Plan. If a project will add additional capacity to an existing roadway it must be listed in the Plan.

Developing a list of project recommendations is a multi-month process that began in October 2024 and is still ongoing. The attached list of project recommendations to date was compiled through multiple methods:

- Staff met with communities and agencies to discuss potential future projects and needs. Conversations have been guided by reviewing findings from numerous AMATS reports.
- Staff reviewed recommendations from various recent planning studies, including Connecting Communities plans.
- Staff reviewed the previous Plan's (TO2045) list of project recommendations.
- Staff looked at project funding applications submitted by sponsors during AMATS' most recent funding rounds in 2023.

(these latter two methods have been utilized to flesh out additional detail and help put together initial project recommendations for those communities/agencies we have not been able to meet with).

There are several important considerations with this list:

- Projects are divided into three categories: Highway Projects, Transit Projects, and Bike-Ped Projects.
- We are still awaiting responses from some communities/agencies or have not been able to set up conversations with some members. Any communities or agencies who would like

- to discuss any additional projects or needs with AMATS staff should contact Matt Stewart as soon as possible (contact information below).
- Highway projects do not include resurfacing projects or even most pavement reconstruction projects. Funding estimates for maintaining the system are derived from the 2024 AMATS Highway Preservation Needs Report. Roadways proposed to change in function, capacity, or are expanded to be larger in scope are included, however.
- The recently approved 2024 AMATS Highway Preservation Needs Report estimated that preservation/maintenance needs would increase 71% from the 2019 estimate. This is largely due to inflationary pressures and material cost increases. Estimated revenue for all total highway-related needs is significantly less than the preservation need will be (indexed to Year of Expenditure). Consequently, decisions need to be made on how much funding goes toward preserving the system vs. all other needs, including safety improvements, active-transportation projects, and operational improvements, i.e. those projects on the Highway list. There is insufficient funding to maintain our existing system to current standards and make other needed improvements to the transportation network.
- Transit estimated revenue is derived from different sources and the projects on the transit list are built out based on each agency's transit needs, including operating and capital costs and additional services proposed.
- The attached list is not yet fiscally constrained. Project costs have been included where possible. Some of these dollar amounts were provided by the project champions and some were estimated internally.

Staff request that AMATS committee members review this draft list and comment on potential future projects, including the estimated funding amounts. From this draft list, and any subsequent refinement suggestions from AMATS committee members, AMATS will develop a fiscally constrained list of Plan recommendations that will be reviewed at the March AMATS committee meetings as part of the draft TO2050 Plan approval. WHEREAS, the Akron Metropolitan Area Transportation Study (AMATS) is designated as the Metropolitan Planning Organization (MPO) by the Governor, acting through the Ohio Department of Transportation and in cooperation with locally elected officials in Summit and Portage Counties and the Chippewa Township and Milton Township areas of Wayne County; and

WHEREAS, it is the responsibility of this Committee to develop and maintain the Transportation Improvement Program (TIP); and

**WHEREAS**, this Committee has been requested to amend the AMATS FY 2024-2027 Transportation Improvement Program to revise funding for one project:

1. **SUM-IR 76-6.15 (PID 100713)** – Is a project that includes increasing capacity and safety on the "Kenmore Leg" in Akron. This project has received additional funding for the construction phase. Construction is scheduled to begin in FY 2027.

**WHEREAS**, the necessary public involvement has been fulfilled as described in the AMATS Public Participation Plan; and

WHEREAS, it has been determined that the IR 76 project is not exempt from regional air quality conformity analysis and has been analyzed for air quality conformity. An air quality conformity determination that addresses both ozone and PM<sub>2.5</sub> pollutants has been conducted and has shown that the projects will conform to air quality requirements; and

WHEREAS, interagency consultation has occurred on January 8, 2025 and all planning partners concur to use current conformity determination due to no scope changes for this project; and

WHEREAS, AMATS has conducted an environmental justice review of this amendment and determined the amendment contains no adverse impacts; and

WHEREAS, this Committee has analyzed this request and found this amendment to be consistent with Transportation Outlook 2045, the Regional Transportation Plan, and with the availability of federal funds forecasted for the AMATS area.

#### NOW THEREFORE BE IT RESOLVED:

1. That this Committee amends the Transportation Improvement Program FY 2024-2027 as previously specified.

- 2. That this Committee considers the necessary public involvement has been carried out as described in the AMATS Public Participation Plan.
- 3. That this Committee affirms that sufficient federal funding is expected to be available for the Akron Urbanized Area to maintain financial constraint.
- 4. That this Committee reaffirms the air quality conformity determination of Transportation Outlook, the 2045 Regional Transportation Plan.
- 5. That this Committee affirms no adverse impacts regarding environmental justice.
- 6. That this Committee affirms consistency with Transportation Outlook 2045, the Regional Transportation Plan.
- 7. That this Committee authorizes the Staff to provide copies of this Resolution to the appropriate agencies as evidence of action by the Metropolitan Planning Organization.

**DATE:** January 29, 2025

At the AMATS Technical Advisory Committee and Policy Committee on December 5 and December 12, respectively, AMATS staff requested feedback on AMATS position on intercity passenger rail.

In 2022, as part of the Bipartisan Infrastructure Law, the Department of Transportation awarded funds to study intercity passenger rail corridors through the Federal Railroad Administration. Three Ohio corridors received funding for study, including the Cleveland-Columbus-Dayton-Cincinnati (3C&D) Corridor, Cleveland-Toledo-Detroit Corridor, and Chicago, Fort Wayne, Columbus, and Pittsburgh. These corridors do not include any rail stops in the greater Akron region.

On June 14, 2024, the Ohio Congressional Delegation wrote a letter to Director Jack Marchbanks of the Ohio Department of Transportation (ODOT) asking that ODOT reconsider including the Akron-Canton area in any corridor study that the agency conducts. On July 8, 2024, Director Marchbanks responded to the Delegation, explaining that adding the Akron-Canton region to the existing corridors was not feasible due to cost, projected travel time increases and additional mileage. The Director also pointed out that the region does not have adequate existing rail facilities to support intercity passenger rail and therefore could not be added to the corridors under consideration.

Since that time, there have been some preliminary discussions to determine appropriate next steps with regards to intercity passenger rail. AMATS staff discussed the issue with the TAC and Policy Committees in December, and the Policy Committee asked the staff to develop a resolution outlining AMATS support for intercity passenger rail in the region.

The attached resolution supports intercity passenger rail being included in AMATS long range transportation plan, *Transportation Outlook 2050* and resolves to support local efforts to study potential intercity passenger rail in greater Akron.

WHEREAS, the Akron Metropolitan Area Transportation Study (AMATS) is designated as the Metropolitan Planning Organization (MPO) by the Governor, acting through the Ohio Department of Transportation and in cooperation with locally elected officials in Summit and Portage Counties and the Chippewa Township and Milton Township areas of Wayne County; and

WHEREAS, it is the responsibility of this Committee to conduct continuing, comprehensive, and cooperative (3C) planning process for regional transportation planning for Greater Akron; and

WHEREAS, it is the responsibility of this committee to consider all modes of transportation, including intercity passenger rail, to improve the region's transportation system; and

WHEREAS, the Infrastructure Investment and Jobs Act (IIJA), Public Law 117-58, authorized the Secretary of Transportation to establish the Corridor ID Program to facilitate the development of intercity passenger rail corridors (49 U.S.C. 25101(a)). The Federal Railroad Administrator is delegated the authority to establish and administer the Corridor ID Program (49 CFR 1.89(a)); and

WHEREAS, in 2022 the Corridor ID Program awarded federal funds for the study of potential intercity passenger rail corridors; and

WHEREAS, Ohio received these federal funds to study the Cleveland-Columbus-Dayton-Cincinnati (3C&D) Corridor, Cleveland-Toledo-Detroit Corridor, and the Chicago, Fort Wayne, Columbus, and Pittsburgh; and

WHEREAS, the Corridor ID Program did not identify any corridors that included rail stops or connections to the Greater Akron area; and

WHEREAS, the Ohio Rail Development Commission was the grant recipient for the 3C&D Corridor; and

**WHEREAS**, On June 14, 2024, Ohio's Congressional Delegation wrote a letter to the Ohio Department of Transportation, requesting an intercity passenger rail stop at the Akron-Canton-Regional Airport or another location in the Akron-Canton area to be added to the study; and

**WHEREAS**, the Ohio Department of Transportation Director Jack Marchbanks, responded on July 8, 2024 and stated that adding an Akron/Canton stop to current rail corridors would add mileage, travel time, and costs; and

**WHEREAS**, The Ohio Department of Transportation Director recommended the region conduct a preliminary analysis of intercity passenger rail routing to determine feasibility; and

WHEREAS, this Committee supports intercity passenger rail that connects greater Akron to an expanded rail network; and

**WHEREAS,** AMATS is currently developing its long-range transportation plan, *Transportation Outlook 2050*.

#### NOW THEREFORE BE IT RESOLVED:

- 1. That this Committee supports intercity passenger rail coming to the greater Akron region.
- 2. That this Committee directs staff to include its support for intercity passenger rail in the AMATS long range transportation plan, *Transportation Outlook 2050*
- 3. That this Committee supports local efforts to develop a long-term strategy for intercity passenger rail in greater Akron that connects to an expanded rail network.
- 4. That this Committee supports local efforts to secure future grant opportunities for the study of intercity passenger rail in greater Akron that connects to an expanded rail network.
- 5. That this Committee authorizes the Staff to provide copies of this Resolution to the appropriate agencies as evidence of action by the Metropolitan Planning Organization.

The purpose of this memorandum is to document the method transportation conformity is demonstrated for the AMATS *Transportation Improvement Program (TIP) FY 2026-2029* and *Transportation Outlook 2050*.

New United States Department of Transportation (USDOT) conformity determinations are required every time a new TIP or Regional Transportation Plan is completed or updated. Nonattainment areas, through a process called transportation conformity, are required to demonstrate that emissions from mobile sources will not exceed the allowable limits for ozone and fine particulate matter (PM2.5) that have been established by the Ohio Environmental Protection Agency (OEPA) in the State Implementation Plan (SIP). Transportation conformity determinations ensure that the transportation sector contributes to an area's progress toward meeting national ambient air quality standards.

Before analysis began, an interagency consultation call (IAC) took place on November 13, 2024. AMATS updated its travel demand model to conduct the analysis considering the latest planning assumptions. This conformity analysis reflects the aggregate regional mobile emissions generated by vehicles using the transportation system recommended in the TIP and the Plan.

Conformity is demonstrated when the forecasted regional emissions are below the applicable SIP budgets that have been established by OEPA. To that end, an air quality analysis has been completed as shown in the attached **Executive Summary**. The conformity analysis demonstrates that the TIP and Plan are in compliance with the applicable air quality standards.

#### STAFF RECOMMENDATION

Resolution 2025-03 affirms the results of the attached conformity analysis demonstrating transportation conformity for *Transportation Improvement Program (TIP) FY 2026-2029* and *Transportation Outlook 2050* as part of the Cleveland-Akron-Lorain air quality nonattainment area. The Staff recommends approval.

#### **Executive Summary**

#### What is required?

Nonattainment areas, through a process called transportation conformity, are required to demonstrate that emissions resulting from planned transportation system improvements will not exceed an area's emissions budgets. The U.S. Department of Transportation (U.S. DOT) issues nonattainment areas formal transportation conformity determinations. U.S. DOT issues these determinations if a quantitative analysis demonstrates that emissions from vehicles traveling on the planned transportation system are less than the area's emissions budget (or other emission target in the absence of an approved budget). Transportation conformity determinations ensure that the transportation sector contributes to an area's progress toward meeting national ambient air quality standards.

The Metropolitan Planning Organizations (MPOs) and the Ohio Department of Transportation (ODOT) must reestablish conformity for the 2006 and 2012 fine particulate matter (PM<sub>2.5</sub>) standards and for the 2008 and 2015 8-Hour ozone standard based on the adoption of the State Fiscal Year (SFY) 2026-2029 Transportation Improvement Program (TIP) and 2050 Transportation Plan. Because conformity is determined on a nonattainment area, rather than on a sub-area basis, each of the area's planning partners must approve a new conformity finding based on these updates. The analysis for each standard covers the pertinent portions of the counties of Ashtabula, Cuyahoga, Geauga, Lake, Lorain, Medina, Portage and Summit. The current analyses reflect a comparison of projected transportation emissions against the approved budgets for each standard.

#### Why are these tests required?

These tests are required because all areas with a current or former designation of nonattainment must maintain conformity findings for the designated pollutants. The tests ensure that transportation planning efforts will not hinder efforts to bring the area into attainment of the standards or maintain attainment of the standards.

#### What tests are being conducted?

The first test is a comparison of projected emissions against the draft budgets for ozone precursors (volatile organic compounds (VOCs) and nitrogen oxides (NOx)). The second test is a comparison of projected emissions with draft budgets for PM2.5 and NOx. For all tests, projected emission levels beneath the respective budgets is considered conformance with the goals of the Clean Air Act.

#### What are the results of the tests?

The results of the tests, as displayed in the following tables, are that the area's existing plans, programs, and projects meet the conformity requirements.

WHEREAS, the Akron Metropolitan Area Transportation Study (AMATS) is designated as the Metropolitan Planning Organization (MPO) by the Governor, acting through the Ohio Department of Transportation (ODOT) and in cooperation with locally elected officials in Summit and Portage Counties and the Chippewa Township and Milton Township areas of Wayne County; and

WHEREAS, the United States Environmental Protection Agency (USEPA) establishes air pollution standards pursuant to the Clean Air Act for the preservation of public health and the environment; and

**WHEREAS**, Portage and Summit Counties are included in the USEPA Cleveland-Akron-Lorain 8-Hour Ozone and PM<sub>2.5</sub> Nonattainment Area designations; and

WHEREAS, the MPOs and ODOT must reestablish conformity for the 2008 and 2015 8-Hour ozone standards and the 2006 and 2012 fine particulate matter (PM<sub>2.5</sub>) standards as a result of the adoption of all FY 2026-2029 Transportation Improvement Programs and 2050 Long Range Transportation Plans (LRTP) amendments; and

WHEREAS, conformity is determined on a nonattainment area rather than a sub-area basis and each of the area's planning partners must approve a new conformity finding for the area based on these updates; and

WHEREAS, pursuant to USEPA regulations 40 CFR Part 93, Regional Transportation Plans and TIPs in non-attainment areas are required to demonstrate transportation conformity with the State Implementation Plan (SIP); and

WHEREAS, the attached air quality conformity analyses compares the projected transportation motor vehicle emissions against the budgets identified in the SIP for each standard for the pertinent portions of the counties of Ashtabula, Cuyahoga, Geauga, Lake, Lorain, Medina, Portage and Summit; and

WHEREAS, interagency consultation has occurred on November 13, 2024 and all necessary coordination between the Cleveland-Akron-Lorain Air Quality area partners: Erie Regional Planning Commission for the Lorain County portion of the City of Vermilion; AMATS for Portage and Summit Counties; NOACA for Cuyahoga, Geauga, Lake, Lorain, and Medina Counties; and ODOT for Ashtabula County, has occurred to establish conformity under the eight-hour ozone and fine particulate matter standards; and

WHEREAS, the conformity analyses demonstrate that the NOACA, AMATS, and ERPC TIPs and LRTPs in the eight county Cleveland-Akron-Lorain air quality nonattainment area are in conformity with the USEPA air quality standards.

#### NOW THEREFORE BE IT RESOLVED:

- 1. That this Committee affirms its approval of the attached air quality conformity analysis for the eight county Cleveland-Akron-Lorain air quality maintenance area for the 2008 8-hour Ozone standard, and serious nonattainment area for the 2015 8-hour Ozone standard.
- 2. That this Committee affirms its approval of the attached air quality conformity analysis for the eight county Cleveland-Akron-Lorain air quality maintenance area for 2006 and 2012 PM<sub>2.5</sub> standards.
- 3. That this Committee affirms the consistency between the AMATS *Transportation Improvement Program FY 2026-2029* and *Transportation Outlook 2050*, and the State Implementation Plan for air quality.
- 4. That this Committee affirms interagency consultation has occurred between its non-attainment partners (NOACA, ERPC, AMATS, and ODOT) to ensure conformity analyses.
- 5. That this Committee authorizes the Staff to provide copies of this Resolution to the appropriate agencies as evidence of action by the Metropolitan Transportation Policy Committee.
