## Introduction


The Federal Highway Administration (FHWA) defines obligation as the federal government's legal commitment to pay or reimburse an entity for the federal share of a project's eligible cost. Obligation does not necessarily indicate expenditure or project completion; only that the project has been approved by the government for reimbursement. In other words, obligated funds are considered "used" even though no cash is transferred.

An obligation is a legal commitment: the Federal government's promise to pay a State for the Federal share of a project's eligible cost. Projects for which funds have been obligated are not necessarily initiated or completed in the program year, and the amount of the obligation will not necessarily equal the total cost of the project. For FHWA projects, obligation occurs when a project agreement is executed and the State/grantee requests that the funds be obligated. For FTA projects, obligation occurs when the FTA grant is awarded.

This report includes the status of all federal transportation projects in the Greater Akron area that had funds obligated between July 1, 2024 and June 30, 2025.

## Obligation Report

During FY 2025, \$178.6 million of federal transportation funding was expended in the AMATS area. Of this total, \$146.8 million was for highway projects and \$3.1 million for transit projects. Most of the remaining funding (\$28.6 million) was expended the repayment of GARVEE bonds (state issued bonds that are repaid using federal funds), but funds for several planning activities were also obligated, e.g. AMATS Air Quality Advocacy Program, the Rideshare Program, various ODOT-led studies, and planning funding toward the Safe Routes to School program. The following pie chart is a summary of the percentage of total federal expenditures by mode in the TIP for FY 2025.



## Highway Projects

There are several different types of highway projects listed in the TIP. These include capacity, operational, and projects.


Capacity projects can include the construction of new roadways and adding new lanes to existing roadways to accommodate larger volumes of traffic. In FY 2025 there were \$50.2 million in capacity type projects obligated. Nearly all this funding was related to the I-77 widening in northern Summit County, although a little over \$1 million of this funding was for engineering toward rehabilitation of the Akron Beltway (I-76).

Operational projects which improve the flow of traffic by coordinating traffic signals, adding turn lanes, adding or improving bike/ped facilities, and/or railroad signage improvements accounted for a total of \$44.1 million in obligated project expenditures. Some of the larger operational projects obligated in FY 2025 include Kent’s SR 59/E. Main Street reconstruction, Stow’s SR 91/Darrow Road reconstruction project, and ODOT’s construction of noise walls along I-77 in the City of Akron. These three projects accounted for just over half of the operational projects total.

Obligated maintenance and preservation projects such as resurfacing, reconstruction, or bridge replacements totaled about \$52.5 million. In addition to this being the largest of the three project types by expenditure, it also contains the largest number of projects. Both AMATS and ODOT fund many maintenance projects each year. In 2025, the largest obligations within the

maintenance and preservation category included bridge deck replacement projects along I-480 over Stow Road in Hudson and on Bowery Street over the Ohio and Erie Canal in Akron.

The following pie chart shows the expenditures for each highway project type by federal funding sources.



A subcategory of Highway Projects worth noting is several exclusively off-road bikeway and pedestrian projects. Obligations for these projects totaled just under \$5 million. Two important notes: (1.) This funding is a portion of the funds already noted above, not in addition to it; and (2.) Several projects occurred that included bike and pedestrian elements as part of a larger overall project, but these funds are not included in the table below.

The Highway Project tables, located at the end of this report, are reflective of the various stages of project development that occurred during FY 2025. The tables are divided into projects that had fund obligated toward construction funding, preliminary engineering or right-of-way, planning studies authorized, loans, or were cancelled or delayed. The tables provide detailed information such as locations and limits, type of work, the amount of federal funds programmed for projects, and remaining federal funds.

### **Transit Projects**

As with highway projects, transit projects are also divided into several different types in the TIP. These include capital, operating and planning type projects. Capital projects include purchasing equipment, which is typically new buses. Federal operating expenditures include items such as

personnel salaries, fuel costs and routine maintenance on buses and facilities. Planning activities can include conducting regional transit planning and the measuring of system performance. In FY 2025, however, 100% of all obligated funding—about \$3.1 million—was capital in nature. While many projects occurred in FY 2025, few were obligated within the fiscal year. Most of the projects on the obligated list are de-obligations occurring to close out projects. Only one capital project contributed to the total amount of obligated funding.

The Transit Projects table provides project information such as type of project, the amount of federal funds awarded or programmed and the status of the grant or project in FY 2025.

### **Additional Notes**

Negative amounts listed in the tables below reflect project cost adjustments in the years after a project is sold or when unspent funds are released to close out a project. These negatives were included in the pie chart totals. Also note that if a project was sold in FY 2025 and no funds were released for this project, it is still listed in the tables.

This report reflects the state fiscal year of July 1 to June 30. The Federal Fiscal Year, however, runs from October 1 to September 30. Therefore, there may be some projects obligated after July 1 but before October 1 that are obligated in Federal Fiscal Year 2025. These projects will be noted in next year's report.
